EXPOSURE CONTROLS/PERSONAL PROTECTION

FIRST AID

EYE CONTACT: Check for and remove any contact lenses. IMMEDIATELY flush eyes with running water for at least 15 minutes while keeping eyes open. COLD water may be used. Seek medical attention.
