5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media:** Dry chemical, foam, water spray, carbon dioxide.
- Specific hazards:** Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
- Specific methods:** Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.

- Environmental precautions:** Prevent product from entering drains.
- Methods and materials for containment and cleaning up:** Sweep dust to collect it into an airtight container, taking care not to disperse it. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Handling

- Technical measures:** Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent dispersion of dust. Wash hands and face thoroughly after handling. Use a local exhaust if dust or aerosol will be generated.
