### 4. FIRST AID MEASURES

### 5. FIRE-FIGHTING MEASURES

<b>Suitable extinguishing media:</b>	Dry chemical, foam, water spray, carbon dioxide.
<b>Extinguishing media not to be used:</b>	Solid streams of water
<b>Specific hazards:</b>	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
