4. FIRST AID MEASURES

Inhalation:

4. FIRST AID MEASURES

- Skin contact:** Remove/Take off immediately all contaminated clothing. Gently wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention.
