### FLAMMABLE

## EXPOSURE CONTROLS/PERSONAL PROTECTION

### Avoid all direct contact with product.

Wear protective safety goggles.

Ensure ventilation during use.

After contact with skin, wash immediately.

## FIRST AID

---

EYE CONTACT: Check for and remove any contact lenses. IMMEDIATELY flush

Eyes with running water for at least 15 minutes while keeping eyes open. COLD water may be used. Seek medical attention.

SKIN CONTACT: After contact with skin, wash with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. COLD water may be used. Cover the irritated skin with an emollient. Seek medical attention. Wash any contaminated clothing before reusing.

INHALATION: Remove victim from source of exposure to fresh air. If breathing is difficult administer oxygen. Seek medical attention.

INGESTION: Do not induce vomiting. Give water to victim to drink. Seek medical attention.

## FIRE MEASURES

Ventilate area and wash spill site after pickup is complete. Wash skin immediately with plenty of water. Absorb on sand or vermiculite and place in closed containers for disposal.
