4. FIRST AID MEASURES

Inhalation:

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media:	Dry chemical, foam, water spray, carbon dioxide.
Extinguishing media not to be used:	Solid streams of water
Specific hazards:	Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
Specific methods:	Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.
Special protective equipment for firefighters:	When extinguishing fire, be sure to wear personal protective equipment.

Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
Environmental precautions:	Prevent product from entering drains.
Methods and materials for containment and cleaning up:	Absorb spilled material in a suitable absorbent (e.g. rag, dry sand, earth, saw-dust). In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
Prevention of secondary hazards:	Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

7. HANDLING AND STORAGE

Handling

Technical measures:	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapor or mist. Keep away from flames and hot surfaces. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system, ventilation.
Advice on safe handling:	Avoid contact with skin, eyes and clothing.

Storage conditions:	Keep container tightly closed. Store in a cool, dark and well-ventilated place. Store under inert gas. Store away from incompatible materials such as oxidizing agents.
