EXPOSURE CONTROLS/PERSONAL PROTECTION

FIRST AID

EYE CONTACT: Check for and remove any contact lenses. IMMEDIATELY flush eyes with running water for at least 15 minutes while keeping eyes open. COLD water may be used. Seek medical attention.

Ventilate area and wash spill site after pickup is complete. Wash skin immediately with plenty of water. Absorb on sand or vermiculite and place in closed containers for disposal.
