5. FIRE-FIGHTING MEASURES

- Specific hazards:** Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
- Specific methods:** Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.

In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
- Prevention of secondary hazards:** Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system, ventilation.
