#### 4. FIRST AID MEASURES

#### 5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media:** Dry chemical, foam, water spray, carbon dioxide.
- Extinguishing media not to be used:** Solid streams of water
- Specific hazards:** This substance may polymerize explosively when heated or involved in a fire. Container may explode when heated. Combat fire from a sheltered position. Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
- Specific methods:** Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Keep containers cool by spraying with water. Eliminate all ignition sources if safe to do so.
- Special protective equipment for firefighters:** When extinguishing fire, be sure to wear personal protective equipment.

#### 6. ACCIDENTAL RELEASE MEASURES

- Personal precautions, protective equipment and emergency procedures:** Use personal protective equipment. Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
- Environmental precautions:** Prevent product from entering drains.
- Methods and materials for containment and cleaning up:** Absorb spilled material in dry sand or inert absorbent before recovering it into a covered container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

#### 7. HANDLING AND STORAGE

##### Handling

- Technical measures:** Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapor or mist. Wash hands and face thoroughly after handling. Use a ventilation, local exhaust if vapor or aerosol will be generated.
- Advice on safe handling:** Avoid contact with skin, eyes and clothing.

##### Storage

- Storage conditions:** Keep container tightly closed. Store in a refrigerator. Store away from incompatible materials such as oxidizing agents.
