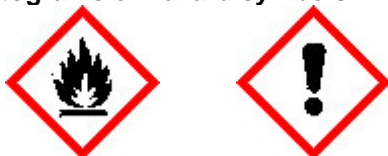

##### [Prevention]

### 5. FIRE-FIGHTING MEASURES

<b>Suitable extinguishing media:</b>	Dry chemical, foam, carbon dioxide.
<b>Extinguishing media not to be used:</b>	Water (It may scatter and spread fire.)
<b>Specific methods:</b>	Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Keep containers cool by spraying with water. Eliminate all ignition sources if safe to do so.
<b>Special protective equipment for firefighters:</b>	When extinguishing fire, be sure to wear personal protective equipment.

### 6. ACCIDENTAL RELEASE MEASURES

<b>Personal precautions, protective equipment and emergency procedures:</b>	Use personal protective equipment. Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc.
<b>Environmental precautions:</b>	Prevent product from entering drains.
<b>Methods and materials for containment and cleaning up:</b>	Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
<b>Prevention of secondary hazards:</b>	Remove all sources of ignition. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

#### Handling

<b>Technical measures:</b>	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapor or mist. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapor or aerosol will be generated.
